Committee Reports:

• **Children's Garden:** Terrie was unable to attend tonight's meeting but had emailed Karen to report that the garden has donated approximately 152.7 pounds of food to CFI.

Progress on all the various projects in the garden is going well and Terrie always welcomes volunteers for help.

- Debbie Balding reported that the committee was also able to get more mulch for the paths that came from the Community Center's facilities folks.
- Program Committee: Laura Caple announced the August MGV meeting will be at the Hog Barn at the Fair Grounds; Gary Connelly will speak about the Invasive Plant Council and their process for prioritizing removal, ending landscape sales (such as for Bradford Pears), and other measures.

The September meeting will be about food preservation (location TBD)

October we will be meeting at the Athens library to hear from a speaker about gardening for climate change (the MGV meeting will be at 5:30 and the speaker will begin at 6:15)

New/Other Business:

 - o After some discussion about the options, Karen suggested that we take a vote
 - 8 voted in favor of the local vendor option and 5 voted in favor of the non-local option
 - The local option is Zones and the Zones option comes with a stand
- Ed Getting information about MGV volunteers needing Safe Food Handling training to be able to donate veggies. Ed is working with a group to do a 1.5 hour training; stay tuned for more info.
- Ed- Athens Co. Fair: Fair is early August and we will have a booth again at the Fair and looking for a topic/theme to have at the booth. Please send Ed ideas for the booth and/or if you are able to volunteer at the booth. Volunteers will still need to pay the entrance fee.
- Karen Keep in mind that the MGV Annual Conference is coming up October 12 -14. We have \$350 designated to reimburse those paying to attend the conference.
 - To qualify for the reimbursement assistance, you will need to have attended at least 3 monthly meetings, and have at least 15 volunteer hours

The \$350 is the total allocated for reimbursement assistance so, if 4
people apply for assistance then, if they qualify, everyone will receive
\$87.50 reimbursement support
